

Put your healthcare funding account to work

Premera Blue Cross has partnered with Optum Financial to administer your healthcare funding account. Here are some steps to get started:

1 Activate your card

Your ID card will have a sticker on it. Call the number on the sticker or sign in to your account on premera.com to activate before you make a purchase.

2 Use your card

Pay for eligible expenses at qualified healthcare merchants where debit cards are accepted. The purchase is paid for with money available in your account.

You can use your account to pay for eligible expenses for yourself and your eligible dependents. Payments made for ineligible expenses or on behalf of ineligible dependents, will have to be reimbursed to your account.

For more information about eligibility, refer to IRS Publication 969.

If you do not have enough funds in your account

The merchant may allow you to pay with the amount left in your account and another form of payment for the balance. Or, you may pay for the entire expense out of pocket and submit a reimbursement request through your account on premera.com.

Know the approved healthcare merchants

Your card is programmed to work only at approved healthcare merchants such as doctors' offices, pharmacies, and hospitals.

Visit premera.com/merchants for an up-to-date list of approved healthcare merchants.

For purchases at healthcare merchants that are not approved, you must use another form of payment and then submit a new claim for reimbursement online.

Note the expiration date on your card*

Your card is good through the last day of the month listed on your card.

3 Save your receipts

Although your healthcare payment card eliminates the need to file paper claims, always save your receipts. You may be required to submit them to validate a claim or for tax purposes.

A non-itemized cash register tape, credit card receipt, or canceled check alone is not proper proof of your purchase.

The receipt must contain the following information:

- Name of person receiving service
- Date of service
- Name and address of provider
- Description of the service or product purchased
- Amount charged

1 Sign in at premera.com

2 Select View Your Personal Funding Account

To manage your account, you can use the “I Want To” dropdown to quickly find the task you want.

Check your account balance

You can easily view your balances and account information on the account tabs.

Track and pay your claims

Select Claims to view existing claims and set up recurring claims.

Know your eligible expenses

Eligible healthcare expenses can vary by plan. To see yours, select Help and then Qualified Medical Expenses.

Make a payment or get reimbursed

To make a payment on a qualified expense, select Pay My Provider or Reimburse Myself.

Go paperless

To request paperless health savings account (HSA) statements, select “I Want To,” then “View Statements,” and follow the easy steps to update your delivery preference.

Request or report cards

Order a replacement card, request an additional card, or report a card lost or stolen in the My Payment Card section.

Use the Optum Financial mobile app

- Check your balance, payments, and claims activity
- Send payments to your providers or request reimbursement
- Use photo upload for claims documentation
- Set up direct deposit, enter reoccurring claims, and add family members
