

SEPARATION FROM EMPLOYMENT CHECKLIST

SEPARATION PROCESS WITH THE CITY

- Submit signed resignation letter to Supervisor and cc Human Resources Dept.
- Human Resources Dept.(HR) will send meeting notice for separation review and exit interview
- Uverify address on record with HR/Notify HR of any change during the year for W-2 mailing
- Contact HR to finalize last day worked and discuss final payroll including vacation accruals
- Contact Department Supervisor for check out procedures/return of all City property
- Park in Visitor Parking on last day if applicable

DEPARTMENT OF RETIREMENT SYSTEMS (DRS) - 401(a) Retirement Plan

- Register for online access to DRS personal account: <u>www.drs.wa.gov</u>
- □ Investigate plan provisions for contributions withdrawals or rollovers to qualified plans
- Contact DRS to request future Annual Statements be mailed to home address
- Update future address and beneficiary changes directly with DRS @ 1.800.547.6657

HEALTH INSURANCE OPTIONS

- City paid benefits end the last day of the month during the last month of employment
- COBRA information on continuation of coverage/cost will be mailed to address on record
- □ Investigate other Individual Health Care Options
- Participants of Flexible Spending Account (FSA): Check balances to avoid forfeitures

LIFE INSURANCE OPTIONS

- Request <u>Group Life Insurance Conversion Request</u> form from HR if interested in continuing an individual life insurance policy. Eligibility and terms may vary.
