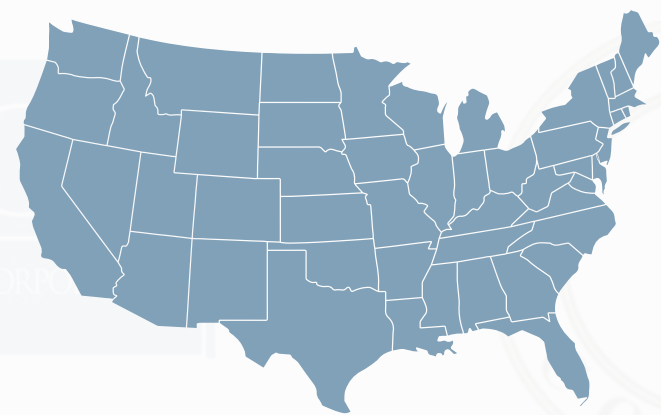
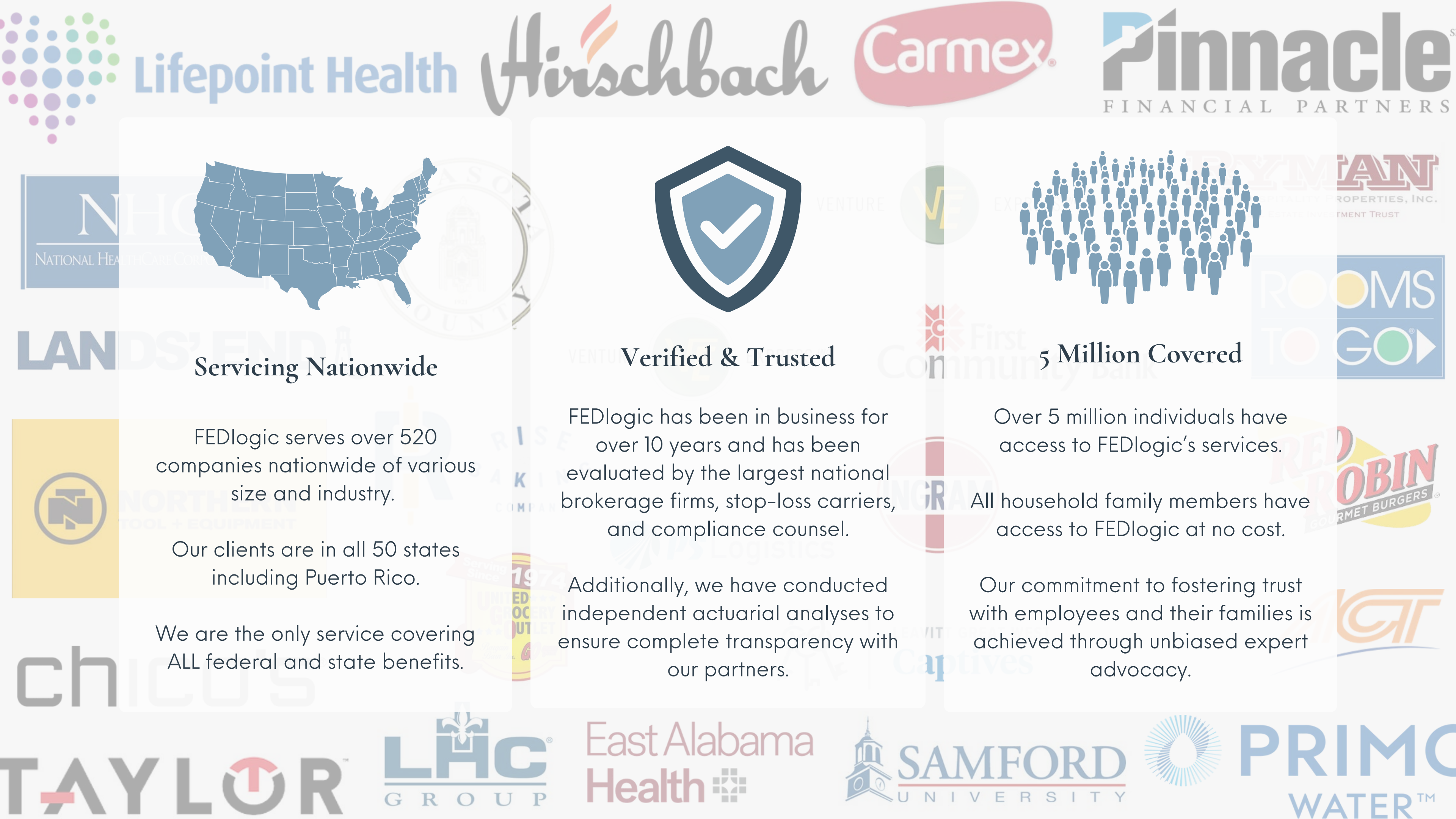


A Mission *that drives us*
