Under the current Internal Revenue Code, if you enroll anyone who is not your dependent for tax purposes, the value of that person's health insurance coverage is taxable to you and thereby treated as income – otherwise known as imputed income. This means that the full cost of the health coverage for that person, less the amount of your after-tax contribution toward the cost of that person's health coverage, is added to your income and subject to ordinary federal and any other applicable payroll taxes without an increase in cash compensation. The amount will be shown on your pay checks throughout the year and will be reported on your W-2 form at the end of the calendar year. This additional taxable income will not be included when calculating other benefits, such as earnings for the MEBT plan. In addition, your contribution toward the cost of health coverage for anyone who is not your legal dependent for tax purposes must be made on an after-tax basis.
