# **Captain Crocker Retires**

As I left his office he stated, "couldn't ask for much more in a career." And that is a perfect summary of the story I'm about to share with you.

Captain Scott Crocker started with the city of New Hope as a police officer on Feb. 1, 1985. At that time, the State of Minnesota had in place a police recruitment system that officers could register with; cities could then review their information and contact the candidates for interviews. New Hope was one of the cities that asked Scott to interview. He had worked here in New Hope at Lakeside Limited, a manufacturing facility on Boone, during school breaks so he was familiar with and liked the area. He was on the shortlist for other agencies, but New Hope fast-tracked his process and offered him a position that he accepted. Richfield tried to woo him away a couple of months later, but Scott had found his second home. He did work part-time at Metro Transit for about 20 years during his tenure here at New Hope, but never strayed any further.

Scott had many great experiences as an officer with the city. One of which was as part of the SWAT team. When he started it was just Golden Valley and New Hope police departments, and then Robbinsdale joined about the same time he did. At one point he served as assistant commander.

He created and managed the first defensive tactics program for the department. Prior to that, what had been offered was through the FBI. Scott had officers train at his home, as the department didn't have the space or equipment for any sort of needed training. He worked with a Crystal officer on the endeavor and coincidentally they shared the same birthdate.

One of the defining moments of Scott's life was being the first New Hope exchange officer in the ELATE (European Learning and Training Experience) program. In 1994, he

traveled to London for three weeks, two weeks learning about law enforcement and the final week on vacation. He is still fast friends with a couple he met as part of the program and has exchanged visits with them over the years. His counterpart from the program recently retired from the Ministry of Defence after 40 years, so post-retirement Scott looks forward to returning to England and visiting them once again.

In April of 1997, Scott was awarded employee of the quarter for his work as an assistant and then the head advisor with the New Hope Explorer Post for many years. While working with the Explorers, the team won third place in the national competition for hostage negotiations.

In 1999, Scott was promoted to sergeant. He told me that over the years as he applied for positions, he was often "the bridesmaid, not the bride." And while he didn't have the goal of being promoted, based on his experience and initiative over the years, it fit. Then in 2011, he was promoted to captain. He recalls one of the questions during the interview, "What did you do to prepare to be captain?" His response, "Nothing, I just did what needed to be done." Apparently, they saw it the same way.

What of the changes? Scott recalls using a clipboard and notepad when being dispatched, at that time by Golden Valley. It was good having the local dispatch as the dispatchers knew the area, but it meant the officers had to be on their toes with listening and recording what they heard. When the MDCs (mobile computers) were deployed the number of officer



-involved vehicle collisions increased, but as officers adjusted it was an improvement, as the amount and accuracy of information increased efficiency in responses. He recalls a couple of models of police vehicles that provided challenges, such as the inability to go fast, or were a pain to refill because of the hydrogen fuel used. He recalls using a lighter to thaw the padlock at public works so he could fill his squad, versus using the gate opener that exists now. A more recent change that he applauds is the addition of the fitness room to City Hall; going across town to the gym versus across the hall makes a tremendous difference when working a 12-hour shift.

Scott has many fond memories: his first time on patrol after passing FTO (field training) and driving down the street humming the theme song to Hawaii-5-0; co-workers he admired such as Mike Mitchell, one of his FTOs; and one time on dogwatch when he woke up and ran out the door when he saw that the clock read 11:10 (his shift started at 11 p.m.), only to find out it was 11:10 a.m. He's also grateful for a supportive Council over the years.

Scott is going to miss the sense of comradery and the great people that he has the privilege of working with. He will also miss the puzzles that come with operating a department, the things that sometimes seem like headaches at the time but provide challenges and engagement. He's proud of his tenure and the fact that he's worked with officers as early as badge #2 to the latest to start with the department, #111. And he has great admiration for those entering law enforcement currently.

**Advice?** One, he's advised Captain Johnson not to share his card carte blanche, there will be plenty of people and tasks looking for his time. Two, do things for the department and city, not just for yourself. Three, be as kind as you can be.

**What's next?** He has no definitive trips planned because of the ongoing pandemic. With a school-age daughter still at home and pets, traveling during the school year would be limited anyway. But he is looking forward to working on projects around the house and being able to focus on himself and his health more. He is planning to spend more time during the summer in Park Rapids at his dad's. And he *might even occasionally sleep in*.
