This notice is being provided pursuant to Minn. Stat. Sec. 181.032 and is not intended to, and does not, form a contract between Scott County and the employee.

- d. Federal, State, Social Security, Medicare, and PERA deductions shall be made according to law and tax tables and/or deduction schedules disseminated.

- f. Deductions for Labor Union participation shall also be made as legally authorized.
