- How to Give Investment Instructions. You may direct the investment of your account balance and future contributions among a range of investments available in the Plan. - Limitations on Investment Instructions. You may direct investment of future contributions to your account in whole percentage increments. You may select a maximum 10% allocation to CCI Company Stock. You may direct transfers of your account balance in dollars, shares or whole percentages only. The maximum percentage that you may exchange to the CCI Company Stock is 10%. In the event that you select a transfer in dollars, a 95% limit will be enforced so that if the market drops and the dollar amount is no longer available, the entire transaction will not reject. Officers and other specific positions are restricted from purchasing CCI Company Stock. If you have enrolled in the Managed by Morningstar advice service, investment allocation and exchange transactions in your account must be sent by Morningstar.
