#### Save with PPO

#### Set up an online account

#### Check in without an ID card

In this incentive plan, Delta Dental pays 52.5% of the PPO contract allowance for covered diagnostic, preventive and basic services and 52.5% of the PPO contract allowance for major services during the first year of eligibility. The coinsurance percentage will increase by 7.5% each year (to a maximum of 75%) for each enrollee if that person visits the dentist at least once during the year. If an enrollee does not use the plan during the calendar year, the percentage remains at the level attained the previous year. If an enrollee becomes ineligible for benefits and later regains eligibility, the percentage will drop back to 52.5%.
