## **Open Enrollment 2024 – We Heard You!!**

## **Open Enrollment will be October 30 - November 11, 2023**

PASSIVE ENROLLMENT: All 2023 benefit elections will rollover automatically if you do NOT act. YOU MUST elect your HSA and FSA as they will not rollover to 2024.

# THIS IS YOUR OPPORTUNITY TO CHANGE YOUR BENEFITS TO MEET YOUR NEEDS!

### **Qualifying life events include:**

- ✓ Your marriage
- ✓ Your divorce or legal separation
- ✓ Birth or adoption of an eligible child
- ✓ Change in you or your spouse's work status that affects either of your benefits
- ✓ Change in residence or work site that affects your eligibility for coverage
- ✓ Change in your child's eligibility for benefits
- ✓ Receiving a Qualified Medical Child Support Order (QMCSO)

Request for coverage due to a qualifying life event must be made within 30 days of the event.

## **Open Enrollment Reminders**

## October 30, 2023 – November 11, 2023

### Remember:

- If you take our medical benefits, all members will be receiving a new Member Card
- This year is a passive enrollment, but you should still review your options, ensure you have a beneficiary listed, and elect your HSA and/or FSA for 2024!
- If you DO NOT act during enrollment:
  - Your 2023 elections will rollover.
  - You will NOT have an HSA and/or FSA election for 2024.
  - You will not be able to make changes after the enrollment period closes unless you have a life event.
- The Global Employee Portal link is provided in your 2024 Benefits Guide.

### Open enrollment is your opportunity:

- To review the benefits package offered for 2024.
- Make changes (add or remove a dependent, change plans) to meet your needs.
- Add or update your beneficiaries.
