Wellness Benefit

Did you know your plan includes our Wellness Benefit¹? This benefit was created to promote annual screenings and we encourage you to take advantage of the benefit offered. The benefit pays according to a fixed schedule once per covered person, per calendar year and it pays in addition to your other coverages.

DocuSign® is online e-signature platform that enables you to submit claims without any printing, mailing, faxing or scanning. We simply send the form to your current email, you can fill out the form completely online, and we automatically receive it once you are done.

There are nearly 20 tests² covered, including:



- Blood test for lipids including total cholesterol, LDL, HDL and triglycerides
- · Breast ultrasound or mammography
- Chest x-ray
- Colonoscopy
- Electrocardiogram (EKG)
- Echocardiogram (Echo)
- Immunizations (such as flu shots or the COVID-19 vaccination)
- Interscholastic sports physical exams
- Pap smear
- PSA (blood test for prostate cancer)
